SUBJECT: Bond Forfeiture

Pursuant to Ohio Revised Code Sections 1509.04, 1509.03, and 1509.071, the Chief of the Division of Oil and Gas Resources Management (“Chief” or “Division”) makes the following Findings and issues the following Orders:

BACKGROUND:

- (1) Big Sky Energy, Inc. (“Big Sky Energy”) is the “owner,” as that term is defined in R.C. 1509.01(K), of 286 oil and gas wells in Ohio (see attached list). Big Sky Energy is registered with the Division as owner number 1333.
- (2) On February 24, 2011, the Division received surety bond number B-0347222 in the amount of fifteen thousand dollars (\$15,000) from the Cincinnati Insurance Company. This bond was filed with the Division pursuant to R.C. 1509.07.
- (3) On November 2, 2015, the Division issued Chief’s Order No. 2015-535 to Big Sky Energy, ordering Big Sky Energy to suspend all its operations in the State of Ohio for failure to maintain liability insurance, in violation of R.C. 1509.07. Chief’s Order No. 2015-535 also ordered Big Sky Energy to either obtain liability insurance as required by R.C. 1509.07(A) in the amount of \$3,000,000, and file proof of insurance with the Division; or Transfer all wells owned by Big Sky Energy to an owner who has obtained insurance that is required under R.C. 1509.07, who is not under a notice of material and substantial violation or under a suspension order, and who is properly bonded in accordance with R.C. Chapter 1509, within thirty days (30) of Big Sky Energy’s receipt of Chief’s Order No. 2015-535.

- (4) On December 12, 2015, Big Sky Energy received Chief's Order No. 2015-535. Big Sky Energy did not appeal Chief's Order No. 2015-535. On January 11, 2016, Chief's Order No. 2015-535 became a final nonappealable order.
- (5) On May 1, 2015, the Division issued Chief's Order No. 2015-207 to Big Sky Energy, ordering Big Sky Energy to properly plug and abandon the Brown #1 Well in accordance with R.C. Chapter 1509 and Ohio Adm.Code 1501:9-11 within thirty (30) days of Big Sky Energy's receipt of Chief's Order No. 2015-207. Properly plugging and abandoning includes completing final restoration as required by R.C. 1509.072.
- (6) On May 4, 2015, Big Sky Energy received Chief's Order No. 2015-207. Big Sky Energy did not appeal Chief's Order No. 2015-207. On June 4, 2015, Chief's Order No. 2015-207 became a final nonappealable order.
- (7) On August 26, 2014, the Division issued Chief's Order No. 2014-270 to Big Sky Energy, requiring Big Sky Energy to submit to the Division annual statements of production for calendar year 2013 for all wells owned by Big Sky Energy no later than 14 days after receipt of Chief's Order No. 2014-270.
- (8) On August 27, 2014, Big Sky Energy received Chief's Order No. 2015-207. Big Sky Energy did not appeal Chief's Order No. 2014-270. On September 26, 2014, Chief's Order No. 2014-270 became a final nonappealable order.
- (9) On May 15, 2014, the Division issued Chief's Order No. 2014-133 to Big Sky Energy, requiring Big Sky Energy to properly plug and abandon the L&L Forbes #1 Well in accordance with R.C. Chapter 1509 and Ohio Adm.Code 1501:9-11 within thirty (30) days of Big Sky Energy's receipt of Chief's Order No. 2014-133. Properly plugging and abandoning includes completing final restoration as required by R.C. 1509.072.
- (10) On May 31, 2014, Big Sky Energy received Chief's Order No. 2014-133. Big Sky Energy did not appeal Chief's Order No. 2014-133. On July 1, 2014, Chief's Order No. 2014-133 became a final nonappealable order.
- (11) On August 14, 2013, the Division issued Chief's Order No. 2013-37 to Big Sky Energy, requiring Big Sky Energy to properly plug and abandon the Cutter #1 Well in accordance with R.C. Chapter 1509 and Ohio Adm.Code 1501:9-11 within thirty (30) days of Big Sky Energy's receipt of Chief's Order No. 2013-37. Properly plugging and abandoning includes completing final restoration as required by R.C. 1509.072.
- (12) Pursuant to R.C. 1509.36, Big Sky Energy appealed Chief's Order No. 2013-37, but the Order was affirmed by the Ohio Oil & Gas Commission. Big Sky Energy's subsequent appeal to the Franklin County Common Pleas was dismissed by that court.
- (13) On August 14, 2013, The Division issued Chief's Order No. 2013-38 to Big Sky Energy, requiring Big Sky Energy to properly plug and abandon the Cutter #2 Well in accordance with R.C. Chapter 1509 and Ohio Adm.Code 1501:9-11 within thirty (30) days of Big Sky

- Energy's receipt of Chief's Order No. 2013-38. Properly plugging and abandoning includes completing final restoration as required by R.C. 1509.072.
- (14) Pursuant to R.C. 1509.36, Big Sky Energy appealed Chief's Order No. 2013-38, but the Order was affirmed by the Ohio Oil & Gas Commission. Big Sky Energy's subsequent appeal to the Franklin County Common Pleas was dismissed by that court.
 - (15) On August 14, 2013, the Division issued Chief's Order No. 2013-40 to Big Sky Energy, requiring Big Sky Energy to properly plug and abandon the ES & D Powelson #2 Well in accordance with R.C. Chapter 1509 and Ohio Adm.Code 1501:9-11 within thirty (30) days of Big Sky Energy's receipt of Chief's Order No. 2013-40. Properly plugging and abandoning includes completing final restoration as required by R.C. 1509.072.
 - (16) Pursuant to R.C. 1509.36, Big Sky Energy appealed Chief's Order No. 2013-40, but the Order was affirmed by the Ohio Oil & Gas Commission. Big Sky Energy's subsequent appeal to the Franklin County Common Pleas was dismissed by that court.
 - (17) Division (A) of R.C. 1509.071 states, in pertinent part, that "[w]hen the chief of the division of oil and gas resources management finds that an owner has failed to comply with a final nonappealable order * * * the chief shall make a finding of that fact and declare any surety bond filed to ensure compliance * * * forfeited in the amount set by rule of the chief. * * * In addition, the chief may require an owner, operator, producer, or other person who forfeited a surety bond to post a new surety bond in the amount of fifteen thousand dollars for a single well, thirty thousand dollars for two wells, or fifty thousand dollars for three or more wells."
 - (18) As of the date of this Chief's Order, Big Sky Energy has failed to comply with seven (7) final nonappealable Chief's Orders: Chief's Order Nos. 2015-535, 2015-207, 2014-270, 2014-133, 2013-37, 2013-38, and 2013-40.
 - (19) Division (E) of R.C. 1509.04 states, in pertinent part, that "[t]he chief may issue a bond forfeiture order pursuant to section 1509.071 of the Revised Code for failure to comply with a final nonappealable order * * *."

FINDINGS:

- (1) The Chief finds that Big Sky Energy has failed to comply with seven (7) final nonappealable orders: Chief's Order Nos. 2015-535, 2015-207, 2014-270, 2014-133, 2013-37, 2013-38, and 2013-40.
- (2) The Chief finds that Big Sky Energy has not complied with all of the requirements of R.C. Chapter 1509 and the rules adopted thereunder.

ORDERS:

IT IS HEREBY ORDERED:

- (1) The entire amount of Big Sky Energy's fifteen thousand dollar (\$15,000) bond, bond number B-0347222, is forfeited.
- (2) Effective immediately, Big Sky Energy shall not operate any wells or produce from any wells in the State of Ohio.
- (3) Big Sky Energy shall not operate any wells or produce from any wells in the State of Ohio until Big Sky Energy posts a new surety bond in the amount of fifty thousand dollars (\$50,000) and files the \$50,000 bond with the Division pursuant to R.C. 1509.07 and the rules adopted thereunder.

Addressee is hereby notified that this action is final and effective and may be appealed pursuant to Section 1509.36 of the Ohio Revised Code. Such appeal must be filed with the Oil and Gas Commission, 2045 Morse Road, Building H-3, Columbus, Ohio 43229-6693, within thirty (30) days after receipt of this Order.

In addition, within three (3) days after the appeal is filed with the Oil and Gas Commission, notice of the filing must be submitted to Richard J. Simmers, Chief, Division of Oil and Gas Resources Management, Ohio Department of Natural Resources, 2045 Morse Road, Building F, Columbus, Ohio 43229-6693.
